Martha Ramcke, president, called the meeting to order at 3:40 p.m. Also present were Diane Pulford, secretary; Dee Dee Swanson, second vice president; and Andrea Thompson, treasurer.

Others attending were Gina Zukel and Linda Thompson, cooperative representatives; Kevin McQuade, maintenance superintendent; Bryan Tims, assistant maintenance superintendent; Dudley Leonard, cooperative attorney; Melva Linville, property manager, and Betsy Kilker, administrative assistant, with Linville Management Services, Inc.

Martha introduced Angie Dyer, a member who has submitted a written application for the board, and the board voted unanimously in favor of appointing Angie to fill the vacancy on the board.

Minutes of the November 17, 2014, meeting were approved.

Open Session

Martha Ramcke, president, welcomed members and called the open session to order at 6:05 p.m. Also present were Dee Dee Swanson, second vice president; Diane Pulford, secretary; Andrea Thompson, treasurer; and Angie Dyer.

Gina presented the on-site manager's report. In December, there were 31

Loose Trash Makes Mess, Attracts Pests

The Trash Fairy, doesn't live here. But if she did, the Trash Fairy would close the lid on the dumpster and pick up the garbage members leave around it.

As it is, trash doesn't magically disappear and leaving the lid open on the dumpster attracts flies and other pests. Please remember to put trash in bags and to place them inside, not next to, a dumpster.

If you pile up turkey bones, candy wrappers, soft drink cans, coffee grounds and banana peels around the dumpsters, they will end up scattered all over the grounds by critters scavenging for food.

Members who empty their trash cans directly into the bin are creating a mess for the maintenance staff. When the dumpster is picked up, loose trash is blown all over the grounds. Litter and garbage strewn throughout the complex are unsightly and unsanitary.

Illegal Dumping

The maintenance staff has evidence that some of the trash in Highleah dumpsters is coming from companies and individuals who are not members of the cooperative. This is illegal. If you believe a motorist throwing trash into a dumpster is not a Highleah member, please get a license tag number and turn the number into the office.

Illegal dumping makes extra work for our maintenance staff and fills up dumpster space intended for use by members.

Carrying Charges Due First Day of the Month

Your carrying charges are due the first day of every month. They become delinquent on the 10th of the month and unpaid accounts are sent to the attorney on the 20th of the month. The checks you write to Highleah Townhouses are being deposited the day they are received.

A new accounts receiveable program allows the checks to be cashed immediately. When you write a check to pay the cooperative, you need to make sure that funds are in your account at that time.

Cold weather auto thefts increased dramatically throughout the Independence area last year when owners started their vehicles and left the motor running and the cars unattended and unlocked.

Even though going to work in a cold car is uncomfortable, having your car stolen is even more bothersome. If you are going to warm up your car before leaving, consider having a spare set of car keys so you can lock it up when you go back inside.

Then, watch the car from a window or door while it is warming up.

Members Asked to Report Suspicious Activities

Whenever you see suspicious activities or persons on Highleah property, please call the Independence Police Department at 9-1-1.

Responding to and investigating all citizen concerns are what the police do. You can help prevent crime by being alert to strangers on the property and questionable behavior. To keep the cooperative safe for all of us, report your concerns to the police.

Security patrols for Highleah are off-duty Independence police officers. They respond to all calls and file reports. The nightly reports are turned in to the Highleah office the next day.

Having this kind of documentation keeps management and the board aware of incidents and helps determine whether additional action is necessary.
