always work to learn how to do my job better.

BOARD MEETING, September 15, 2015 **NEWSLETTER MINUTES**

OPEN SESSION

Board members present: Martha Ramcke, president; Diane Pulford, secretary; Andrea Thompson, treasurer; Angie Dyer and Jordan Baze

Board members absent: Gina Zukel, on-site manager; Linda Thompson, assistant manager; Kevin McQuade, maintenance superintendent

Also attending: Dudley Leonard, cooperative attorney; Betsy Kilker, administrative assistant, and Carmen Detherage, comptroller, for Linville Management Services, Inc.

Martha Ramcke, president, announced that a quorum was present and called the meeting to order at 6:12 p.m.

Martha welcomed members and thanked them for attending. She said enough members were present for the annual meeting but not enough to vote on the bylaws, which requires a majority of the members.

She referred to the official notice of the Annual Membership Meeting mailed to all members as proof of notice of the meeting.

Martha read aloud the minutes of the annual meeting held on September 16, 2014. The minutes were approved as read.

Martha asked for three volunteers to serve as inspectors of election. Vicky Wray, Erin Coover and Frances Chrisman volunteered.

Betsy gave the managing agent's report. She prepared a pie chart illustrating how carrying charges were spent and distributed copies to members. The cooperative's assets are \$12,201,706. Reserves are \$601,345.

Board member Angie Dyer addressed the members. She announced her resignation from the board.

Martha announced that two positions are open on the board of directors: one for a two-year term and one for a three-year term. Jordan Baze and Tina Windhausen have submitted applications for the board.

Martha asked for nominations from the floor. There were no nominations from the floor and a motion to close the nominations was made and carried.

Candidates fielded questions from the members.

Jordan Baze and Tina Windhausen were elected by acclamation.

Door prize drawings were held. Barbara Harms won \$25; Diane Pulford won \$50; and Kathy Painter won a month's free carrying charges.

Additional prizes were awarded that had been donated by merchants and vendors.

The annual meeting was adjourned at 6:40 p.m.

The board convened for an executive session.

Board Adopts Office Policies

Two traditions were entered into official policy and a new financial agreement plan was introduced earlier this year.

The board approved the way charges are assessed for late fees and for service requests (work orders) to the maintenance staff. Here are the policies.

Carrying charges must be in the drop box by 8 a.m. the next business day after the 10th of the month or a late fee will be assessed on any amount owed.

Payment plans and other financial arrangements must be determined by the board of directors or by the cooperative attorney.

Members are allowed to carry a total of \$200 in maintenance service requests (work orders) up to 12 months. Members will be required to sign a financial agreement plan to make a minimum payment of 1/12th the amount owed every month.

Pet waste clean-up reminder signs and stations with disposal bags have been posted on the property.

We hope to encourage all members to clean up after their pets and keep the grounds neat and clean for everyone to enjoy.

Those who fail to abide by the rule so are sent a notice and given 24 hours to clean up.

Highleah pet rules state: "7. All pet feces must be cleaned up immediately anywhere at all times when the pet is outside the unit on the cooperative grounds. Pet waste must be placed in a plastic bag and disposed of in a proper trash receptacle."

Pet waste is considered unsanitary and annoying to members of all ages who enjoy our grounds. A recent U.S. Geological Survey study of streams and creeks in the Kansas City region showed that bacteria from pet waste is the source of about 25 percent of the bacteria in local waterways.

When pet waste is disposed of improperly, water quality isn't the only thing that suffer your health may be at risk, too. Adults working in their gardens, children playing outside and family pets are at risk for infection from some of the bacteria and parasites found in pet waste.

Complying with Highleah pet waste rules is now easier than ever. Not complying, however, can get expensive.

If pet owners don't comply, maintenance then is dispatched to clean up and members are charged.

Members who refuse to comply with the pet waste rule place their Occupancy Agreements in jeopardy.

New Policy in Place to Eradicate Bed Bugs

Highleah Townhouses, Inc., has adopted a zero-tolerance policy for bed bug infestations.

At the July 21 board meeting, the board approved a Bed Bug Policy effective immediately.

Member Responsibilities

- ✓ Report any suspicion of the presence of bed bugs immediately to the on-site office.
- ✓ Fully cooperate with inspectors, management and pest management professionals during the entire process of eliminating the pests.
- ✓ Continue to help the cooperative by monitoring your unit for bed bugs after treatment has been made.

Cooperative Responsibilities

- ✓ We will take your bed bug problem seriously and will schedule a qualified inspection as soon as possible.
- ✓ We will schedule inspections for adjacent units to assess the extent of the infestation and will treat all units found to be affected by the infestation.
- ✓ We will pre-inspect the day before treatment is scheduled to make sure your unit is properly prepared. We will let you know if anything is not ready.
- ✓ We will assist the pest management professionals in gaining proper access to all areas to be treated.
- ✓ We will make any structural repairs recommended by the pest management professional necessary to eliminate bed bug hiding places. We will caulk and seal any cracks and crevices in the unit.
- ✓ We will schedule follow-up treatments for your unit as necessary and recommended by the pest management professional.
- ✓ We will commit to using the most effective treatment recommended for the infestation. In most cases, heat treatment when available will be used when available.

Treatment will be provided at no cost to the member as long as full cooperation is given. However, should a member fail to cooperate or to follow the instructions for eliminating

the pest or should the member have repeated infestation issues in the unit, the member may be subject to charges for the treatment.

A member's failure to report suspected infestation and/or failure to comply with the necessary procedures for eliminating the pest will result in a violation of the Occupancy Agreement and possible termination of occupancy.
