# BOARD MEETING, August 15, 2011 NEWSLETTER MINUTES

Jim Legge, president, called the meeting to order at 6 p.m. Other board members present were Marsha Clark, first vice president; Dorinda Meihls, secretary; and Dan Hastings, second vice president.

Also attending were Carol Gibson, on-site manager; Gina Zukel, assistant on-site manager; Kevin McQuade, maintenance superintendent; Dudley Leonard, cooperative attorney; and Carmen Detherage, comptroller, and Suzanne Miles, human relations coordinator, with Linville Management Services, Inc.

Four members signed in for the open session.

Carol discussed the on-site manager's report. In July, there were 44 statements of credit, 46 statements of charges due, one attorney referral, 39 defaults, one installation permit received and approved, one eviction in process, six exterminations, two animal violations and two vehicle violations.

The fall garage sale will be on Saturday, September 24, with a rain date of October 1.

Currently, six two-bedroom units and six three-bedroom units are on the market. Three of the units have been sold but are not yet occupied.

The board voted unanimously to accept Carol's report.

Carol was excused.

Kevin presented the maintenance report. In July, 186 work orders were completed. There were two move-ins and two move-outs. Palmer Lawn Professionals moved four times.

Eight rehabs are in various stages of completion.

The playground equipment on the east and south playgrounds has been painted.

Repairs Unlimited estimates the scope of work to repair the damage to 1904 Pembroke Crescent East at \$15,145.29. The cooperative has not yet received an approved scope of work from the insurance company.

The board voted unanimously to accept Kevin's report.

Jim opened the floor to member comments.

Jim thanked members for attending the meeting and the open session ended at 6:20 p.m.
