### **BOARD OF DIRECTORS**

Cooperative members will fill two three-year positions on the board of directors at the Second Annual Meeting Picnic on Tuesday, September 16.

Registration is at 5:30 p.m. and the meeting will begin at 6 p.m. The meeting will be behind the clubhouse and will include a picnic for all members and their families.

To elect new board members, we need a quorum of 20 percent of the membership, present or by proxy. Door prizes will be awarded: first prize of a month's free carrying charges, second prize of \$50 and third prize of \$25. Members must be present to win.

Only members in good standing can vote. Any member with an unpaid balance of more than 30 days cannot vote. If you cannot attend, you may vote by proxy.

Members voting by proxy must appoint another member in good standing to vote on their behalf. No attending member may cast more than his or her vote plus one proxy vote.

### **BYLAWS**

The bylaws were revised by cooperative attorney Dudley Leonard to remove references to FHA and HUD and to update them with the way the cooperative currently operates.

If a majority of members is present, three first prizes will be awarded: three different members will be awarded a month's free carrying charges. Second prize will be \$50 and third prize, \$25.

Only members in good standing can vote. Any member with an unpaid balance of more than 30 days cannot vote. If you cannot attend, you may vote by proxy.

Members voting by proxy must appoint another member in good standing to vote on their behalf. No attending member may cast more than his or her vote plus one proxy vote.

### **OPEN SESSION**

Marsha Clark, president, called the meeting to order at 6:07 p.m. Also present were board members Diane Pulford, first vice president; Martha Ramcke, secretary; Dudley Leonard, cooperative attorney; Gina Zukel and Linda Thompson, cooperative representatives; Kevin McQuade, maintenance superintendent; Bryan Tims, assistant maintenance superintendent; Dudley Leonard, cooperative attorney; Melva Linville, property manager, and Betsy Kilker, administrative assistant, with Linville Management Services, Inc.

Eighteen members signed in.

Minutes of August 13 and July 21 were approved unanimously.

Gina presented the office report. There have been 36 statements of credit, 71 statements of charges due, two attorney referrals, 33 defaults, two reasonable accommodation requests completed and one installation/alteration permit received and approved.

Three units are on the market: two twobedroom units and one three-bedroom unit.

The fall garage sale will be Sept. 20 and 21. Gina will run an ad in the Examiner.

Kevin presented the maintenance superintendent's report. In July, there were 178 requests for service received and 165 approved. There were five move-ins and two move-outs.

Five mowings were completed. The mowing service has asked that members put edging or a small fence around their flowers and plants so that they are not mistaken for weeds and cut down.

Four rehabs are under way.

Marsha asked that members use the side entrance to the clubhouse while repairs are being made to the front entrance.

She reminded members of the annual meeting and picnic on Sept. 16. Two positions are open on the board.

Marsha opened the floor to member comments.

The door prize drawing was held. Angie Dyer was the winner.

The open meeting ended at 6:35 p.m.
