Open Session

Marsha Clark, president, called the meeting to order at 6 p.m. Other board members present were Dorinda Meihls, first vice president; Paula Goth, second vice president; and John Baggs, secretary.

Also attending were Carol Gibson, on-site manager; Dudley Leonard, cooperative attorney; and Melva Linville, property manager, and Suzanne Miles, human relations coordinator, with Linville Management Services, Inc.

Fourteen members signed in for the open session.

Minutes of the April 16 board meeting and the April 23 work session were approved unanimously.

Carol discussed the on-site manager's report. In April, there were 33 statements of credit, 42 statements of charges due, two attorney referrals, 40 defaults, three evictions in process, one installation permit received, four exterminations, one animal and one vehicle violation.

Twenty-seven units are on the market: eight three-bedroom units (four are sold) and 19 two-bedroom units (one is sold). Eight of the units are still occupied.

Marsha read the maintenance report prepared by Kevin

McQuade. In April, 206 work orders were completed. There were two move-ins.

Grounds projects included four mowings, one perimeter fence trimming and an application of herbicide.

Seventeen rehabs are in various stages of completion. Foundation repairs to 17884 Buckingham Court are scheduled.

The board voted unanimously to accept the reports.

Marsha presented the education grant award to Jessica Gall.

Dorinda reported for the Pet Committee. The committee is considering a dog run and a community garden. Marsha reported for the Security Committee. No more bids have been submitted. John reported for Activities. Friday, June 8, at 7 p.m. will be White Elephant Bingo in the clubroom.

Marsha opened the floor to member comments. Jennifer Plemmons won the door prize drawing of a \$25 Quik Trip card.

The open session ended at 6:30 p.m.
