

Office update

One reasonable accommodation request was received, and one installation/ alteration permit was received and approved. Three exterminations were performed.

If your dryer vent looks like this, it needs to be cleaned. Board member and management walked the property and found a lot that looked like this. Please check yours and unclog it. This is a fire hazard.

Window wells are not for storage. Please clear any items that may be in your window well and store inside.

Stakes that are put out when you plant grass seed, must be removed when grass starts growing. They cannot be left out permanently as they are a trip hazard for others. If you got them from the office please return to office when taking them down.

All complaints need to be in writing either by email or dropped off at office. If you are complaining about something and after 2 weeks you see no improvement you need to follow up with the office. A second complaint will be addressed by the management company.

As the end of summer draws near when cleaning up old plants and weeds please do not put yard waste in the regulars dumpsters. We have a dumpster at the storage lot for yard waste. If it is on weekends or after hours when that lot would be locked you may drop off your bags by the maintenance shop door.



Maintenance summary

Kevin reviewed the maintenance report.

In July, 174 service requests were received and 167completed. There were two move-ins and two move-outs.

Ten rehabs are in various stages of completion.

Fine Lines Lawn & Irrigation completed three mowings and fertilized all grass areas. They also treated for weeds and grubs.

Basement sewer lines were replaced in six units for a total cost of \$31,050.

Betsy presented the managing agent's report for July 16 through August 14.

Four applications were approved and one was denied. Three final statements were completed and three are pending.

Processed in accounts payable was \$212,612.09.

Jane opened the floor to member comments.
